You will assess digital learning content against WCAG standards, ensuring our programmes are inclusive and accessible to all learners, implementing recommendations as required. A background in teaching/training and experience with apprenticeships is highly desirable.

1. **Accessibility Review:** Conduct a thorough review of each of our learning programmes to assess compliance with WCAG standards and identify areas for improvement.
2. **Documentation and Reporting:** Provide clear, actionable feedback and reports, against agreed timelines, on accessibility findings for each programme, making recommendations as appropriate.
3. **Collaboration:** Working closely with learning designers, subject matter experts, and other stakeholders, ensure that the recommendations, once agreed, are implemented in all programme material and documentation.
4. **Quality Assurance:** Ensure that all content meets BPP's quality and accessibility standards.
5. **Continuous Improvement:** Stay informed about updates to WCAG guidelines and best practices in accessible learning design.
